Mandate	Mandatory notice concerning the processing of personal data
<p>I hereby authorize and instruct the Organization PI to collectively manage my economic performers' rights in Serbia in accordance with the law, as well as internationally through bilateral agreements with related foreign organizations.</p> <p>I authorize and instruct the Organization PI to claim and charge, in their name and on my behalf, remuneration for all aspects of use of my performances which are subject to mandatory collective management of performers' rights.</p> <p>I also authorize the Organization PI to manage my rights to special remuneration in Serbia and abroad, from import or sale of technical devices and empty carriers of sound, or sound and picture, for which it can be justifiably assumed that they shall be used for copying for personal non-commercial purposes.</p> <p>This authorization may be revoked in writing at any time, having legal effect from January 1st of the following year.</p> <p>If there is an expansion regarding the aspects of mandatory collective management of performers' rights, due to changes of legal regulations, I hereby authorize the Organization PI to also manage my rights in those cases.</p> <p>I agree that the Organization distributes and pays the performers' remuneration on the basis of this authorization in accordance with the Distribution Plan and other acts of the Organization.</p>	<p>Organization PI concerns with the management of economic performers' rights, which includes data collection, processing of data on performers' and rightholders, establishing and updating data collections that are necessary for the management of economic performers' rights. Data which the Organization manages shall be processed automatically and manually.</p> <p>Access of data which the Organization manages is available to: employees in accordance with the internal rules, the data processor, related foreign organizations in accordance with the contract and the law, as well as State authorities on the basis of an appropriate official document for precisely stated data and in accordance with the law. Submission of personal data is required for the management of property rights of performers.</p> <p>The performer or the rightholder has the right to demand in writing, at any time, for all his/her personal data to be deleted from the records of the Organization, with an obligation to settle its obligations to the Organization.</p> <p>Deleting data from the records is considered the revocation of this authorization/mandate. If the performer or the rightholder believes that the Organization has been processing personal data illicitly, he has the right to apply to the Commissioner for Information of Public Importance and Personal Data Protection.</p> <p>If the organization is informed about any illicit data processing, it shall immediately inform the performer or the rightholder and the Commissioner.</p>

I hereby state under material, moral and criminal responsibility, that the information above is correct, and that I shall immediately notify the Organization PI in the case of change of the data within this authorization.

By signing this authorization I give my consent for the processing of personal data which the Organization obtains from me or by other means.

Organization is not responsible for any incorrect data submitted by performers/rightholders, on the basis of which it conducts collective management of rights of performers, in its own name and on their behalf.
